- 4.) **A copy of your Public Liability Insurance, a completed Risk Assessment and a Stamped Addressed Envelope must be included with your booking.**
- 5.) Pitch bookings received after the 31st July, will only be available if space allows. **Late bookings** will be at a rate of £75 per 20ft pitch plus £4 per foot for extra frontage
- 6.) Payment for your stall needs to be in full at time of booking. Cheques made payable to **“Yesterday's Farming Ltd”** (will be banked on receiving)
- 7.) Cancellation refunds are 50% of the booking fee. Refunds will be given if reasonable notice is given (2 weeks before the event) No refunds will be given for cancellations after this date.
